



Introduction

For over 70 years, the Caux Conferences, now known as the Caux Forum have dealt with the challenges facing the global community and human security has always been high on the agenda. Human Security has been described by former United Nations Secretary General Kofi Annan as "Freedom from want, freedom from fear and the freedom of future generations to inherit a healthy natural environment". The global rise of instability of all kinds puts these elements of human security at risk. Pillars of stability depend on decisions made by those in power, but they also depend on each and every one of us.

Progress towards human security is often blocked by entrenched attitudes and difficult relationships which lack dialogue and trust. The forum is concerned, therefore, with enabling both leaders and citizens to work effectively towards an inclusive, democratic approach while seeking inspiration to make fresh steps towards trust-building. Some participants come from countries under authoritarian rule, others from emerging or established democracies. At Caux everyone has the opportunity to share their own experience without judgment, learn from others, and to work together to advance human security by connecting and discussing the best ways to deal with conflict, division, counter-extremism and other challenges. Everyone has a voice in creating stable pillars for their society.

The United Nations Sustainable Development Goals are a global call to action for all citizens to rise up and play their personal role in tackling the social and economic issues that threaten the future of communities around the world. Just Governance for Human Security 2018 will focus in particular on the connection between the United Nations Sustainable Development Goals and the **Six Pillars of Human Security**.

Six Pillars of Human Security

Threats to human security jeopardize society's foundation. The Six Pillars of Human Security: good governance, food security, inclusive economics, social inclusion, sustainability and healing memory bring together members of society to be active in the struggle against threats to peace and stability.

Plenary Sessions

With an emphasis on conversation and discussion rather than speeches, we hope to encourage dialogue throughout the forum, particularly during the morning plenary sessions. Panellists will open the conversation with short statements, and then participants will be invited to join the discussion in a question and answer format.





Our unique, interactive method

This forum brings together people working to advance just governance and human security in their situation. Every participant brings valuable knowledge and insights to the table. Through a combination of interactive sessions: plenaries, participatory peace-building sessions, training and space to reflect, we explore approaches which can help answer personal, national and international challenges.

Opening Keynote Speaker | Former Vice President, Republic of The Gambia Her Excellency, Fatoumatta Jallow Tambajang is the Vice President and Minister of Women's Affairs of The Gambia and a pro-active national women leader, pioneer and chair of the Coalition 2016, which democratically defeated a 22-year dictator. She is a pro-democracy and human rights activist, political coalition builder, former passionate UN international development management practitioner, resource mobilizer and partnership builder with wealth of experience in corporate governance and UN system policy and technical operations, trainer in policy formulation and development management, conflict prevention and management, gender mainstreaming, women's transformative political leadership and social entrepreneurship. She has a wealth of experience in governance and policy issues, having served as Adviser on Women and Children Affairs, and as Health Minister. She has also one time served as Chief Technical Adviser on Gender at UNDP in Liberia from 2000 to 2002. She holds a BA in French Language from the University of Nice, France.



DR MATTHEW OPOKU PREMPEH (GHANA)

Minister of Education, Ghana | MP, Manhiya South Constituency, Ashanti Region, Ghana

Dr. Matthew Opoku Prempeh is the Minister of Education in Ghana and a Member of Parliament for the Manhyia South Constituency in the Ashanti Region of Ghana. Dr Prempeh heads the biggest and most challenging ministry in the country and handles his duties with surgical precision. This has led to the achievement of many of his set targets, the most significant being the successful rollout of the "Free Senior High School Programme" in September 2017. Dr Prempeh has made it his mission to improve learning outcomes and bridge the gap between education and employability in the country. He is championing reforms in various key areas in teaching and learning including elevating the status of Technical and Vocational Education and Training (TVET). He was judged the overall Best Minister of the year 2017 and continues to receive worldwide recognition for his efficiency and effectiveness. Dr Richard Ponzio is Director of the Just Security 2020 Program at Stimson. Previously, he directed the Global Governance Program at The Hague Institute for Global Justice, where he served as Director for the Albright-Gambari Commission on Global Security, Justice & Governance. He brings expertise in the areas of global and national democratic institution-building, global political economy, and the role of international institutions in responding to state fragility, global financial volatility, and population displacement. Richard is a former Senior Adviser in the U.S. Department of State's Office of the Special Representative for Afghanistan and Pakistan and has served in a variety of senior policy and strategic planning positions for the United Nations. He was a Visiting Fulbright Fellow at the Mahbub ul Haq Human Development Centre in Islamabad and completed his doctorate in politics and international relations at the University of Oxford on a Clarendon Scholarship.

She is a Senior Advisor in International Relations within the Romanian Government and Parliament (on behalf of the National Agency for Equal Opportunities, Minister of Labour and Social Justice, and the National Council for Combatting Discrimination). She is also an academic lecturer in Good Governance, Non-Discrimination, Human Security, Human Trafficking, Gender Studies, Cultural Violence and Conflict Transformation at various colleges and institutions in the US and Europe. Her work has produced groundbreaking research on the shifting post-cold war standards of UN nation-states in addressing security, R2P, conflict management, and its implications for civil society. She is a founding member of the Euro-Atlantic Partnership for Sustainable Development and the Editor-in-Chief and founder of several political science and human rights magazines. Recently she became a US State Department Alumna in Sustaining Civic Participation in Minority Communities. She was awarded 'Woman of the Year 2015' in Romania for defending and promoting women's rights.



FARAI MAGUWU (ZIMBABWE)

Director, Centre of Natural Resource Governance, Zimbabwe

Farai Maguwu is the founding Director of the Centre of Natural Resource Governance (CNRG), a leading organization working on improved governance of natural resources in Zimbabwe. He has done extensive research and documentation on human rights abuses and illicit trade in diamonds in Zimbabwe. In 2011 Farai was arrested for his human rights work, charged and detained for 40 days by the Zimbabwean government. In November 2011, Human Rights Watch awarded him with the prestigious Alison Des Forges Award for Extraordinary Activism. He was also honored by Rapaport, a clean diamond campaigner, for protecting artisanal diamond miners in Zimbabwe's Marange region. Farai is a PhD candidate at the School of Developmental Studies, University of Kwazulu Natal and holds an MA in Peace and Conflict Studies from the European University Centre for Peace Studies in Austria and a Master's in Peace and Governance from Africa University.






HAYDEE DIJKSTAL (THE NETHERLANDS)

Haydee Dijkstal is an attorney practicing international criminal law and human rights law before international criminal tribunals, regional human rights courts and domestic courts. Her practice has included work before the International Criminal Court (ICC), International Tribunal for the Former Yugoslavia, Special Court for Sierra Leone and the African Commission and African Court on Human and Peoples' Rights and representing victims, governments and accuseds. She is currently a member of the legal team acting on behalf of the Government of the Comoros and victims for the case concerning the Gaza Freedom Flotilla before the ICC. This work includes Alien Tort Statute, Torture Victims Protection Act and Foreign Sovereign Immunity Act litigation in US Federal Court. She has teamed on high-level cases including for accuseds Abduallah Al-Senussi, Saif Gaddafi, and Charles Taylor, and also for victims from Sudan and Palestine. She is also founder and editor of the UK Small Charity, ICL Media Review, which provides publications of developments in international criminal and human rights law.



RAGHAD AL SAADI (USA)

Principal and Founder, Polar Lights Prime LLC | 2017 Nobel Peace Prize Delegate

Raghad Al Saadi is the founding principal of Polar Lights Prime, a private sector company based in Virginia, USA. She was a delegate of the Nobel Peace Prize Forum (NPPF) 2017 where she presented "mistBit™ – Empowering Women and Children to Combat Sexual & Gender-Based Violence and Human Trafficking in Refugee Camps and Disaster Zones." She has 17 years of a SME/managerial level federal and international experience in capacity building, strategic planning, peace negotiations, human rights, female integration in law enforcement, humanitarian assistance and disaster response programmes. She supported the US Department of State, Homeland Security, the US Mission in Baghdad, the Ministry of Justice in Libya, and NGOs. Raghad holds a Masters degree in Peace Operations from George Mason University.
