

Trust and Integrity in Democracy

The Caux Forum 2023

The Caux Forum 2023 was held in The Caux Palace above Montreux from 17 to 26 to July.

The Opening Ceremony "Strengthening Democracy: The Journey from Trauma to Trust" set the stage for: "Healing the Wounds of the Past" (17-22 July) and "Trust and Integrity in Democracy" (23 - 26 July).

Moving into a Forum on "Trust and Integrity in Democracy" (23-26 July) after the Forum on "Healing Wounds of the Past" was like "completing a circle".



Trust and Integrity in Democracy

Democracy as a form of government is a universal benchmark for human rights protection. Some Governments are deliberately weakening independent checks on their powers, suffocating criticism, dismantling democratic oversight and ensuring their long-term rule, with negative impact on people's rights.

At the very core of The Trust and Integrity in Democracy Forum, an exploration of how Trust and Integrity plays a fundamental role in democracy.



What happened during the "Trust and Integrity in Democracy" Forum?

The "Trust and Integrity in Democracy" provided a stretching yet compassionate community context in which individual introspection and collective inquiry can support radical dialogue and mutual contextual learning.

The survey results indicate the "Trust and Integrity in Democracy" creates a supportive, compassionate context in which participants engaged in courageous, honest conversation – paving the way for reestablishing trustworthiness, tolerance and transparency.



- 90% of the respondents to the survey agreed or strongly agreed that TID equipped them with tools and enhanced trust and in democracy.
- 96% of the respondents to the survey agreed or strongly agreed that TID connected them with individuals and organizations to support and sustain their journey and initiatives to enhance trust and integrity in Democracy. See annex 1 Main survey results

Figures on "Trust & Integrity in Democracy"

- Three-day Forum (Sunday to Wednesday)
- Over 300 participants from 72 countries (Total Caux Forum 555 participants)
- Five plenaries
- Twelve keynote speakers or panelists
- Height workshops
- Three personal stories, one each morning
- Early morning times for Silence, which is a core practice of IofC
- Evenings: on an Oscar nominated film, an evening with the Mothers of Ukraine and an evening celebration of music and dance
- Each, ccommunity time to create a safe space for deeper conversations that matter
- Multiple conversations at other times. Conversations that are often where action is developed for us personally or collectively
- Accommodation of 300 participants, over 1'000 meals served and over 2'000 coffee breaks
- Two thirds of the participants were sponsored for their stay at the Caux Forum
- 3,302 Bednights for the Caux forum with a average length of stay of 6,6 nights

What has come through, time and time again here is this that leadership as we know it now, cannot deliver for the future without integrity. This goes for leadership in every sphere.



Annex 1

Results and comments from the "Trust and Integfrity in Democracy" satisfaction survey

63 participants replied to the TID survey (Approx. 20% of participants). 97% of the participants surveyed found the TID forum useful or very useful. Two participants indicated that they will not recommend the Caux Forum to others.



97% of the respondents to the survey demonstrated willingness to share the Programs/Activities with others in their networks.

90% of the respondents to the survey agreed or strongly agreed that TID equipped them with tools and enhanced trust and in democracy.

97% of the respondents to the survey agreed or strongly agreed that TID connected them with individuals and organizations to support and sustain their journey and initiatives to enhance trust and integrity in Democracy.

86% of the respondents said that listening to the speakers inspired trust and integrity in democracy within them.

Two thirds of the respondents experienced a shift in their trust and integrity for democracy.



Some of the comments from the survey:

"I was able to get the different perspectives of what trust and integrity in democracy mean to different people and how that is being implemented in different parts of the world."

"Ability to discover new dimensions to the topic of democracy. Good speakers. Valuable to meet Ukrainians and have presentation from them."

"I really appreciated the facts that opponents (Cambodian one for instance) were invited."

"It was useful in that it helped me to reflect on democracy and what it represents and how integrity has been lost."

"Many interventions were experiences of significant trustworthiness and integrity. The Minister of Mining in Niger, the authenticity with which Hella spoke. The closing when a Russian woman asked for forgiveness and a Ukrainian woman responded."

"The importance of Caux as a place to enhance our role in today's world and our responsibility as a global team to impact main issues in the world."

"The many different civil initiatives for democratic function, including grassroot and traditional democratic actors (in Africa and Switzerland, for instance). The Swiss experience of democracy should have been formally presented to provoke reflection. The Petition for the Australian Referendum was also worthwhile."
