Please note that all specific details relating to your booking—including rates, payment schedule, cancellation policy, and included services—are outlined in your **individually signed contract**,

By using our website or engaging in a booking with us, you acknowledge that the signed agreement between the organizer and our foundation serves as the sole binding contract for your event or stay. The information below outlines our general approach and policies.

This insurance provides coverage for incidents occurring on-site, including those linked to facility operations or negligence on our part. That said, as a precaution and good practice, we recommend that all clients and participants be individually covered for personal risk, such as accidents, medical expenses, or loss of personal items. The foundation cannot be held liable for issues beyond its direct control.

Governing Law & Jurisdiction

These Terms & Conditions, as well as any contract agreed upon with the Fondation CAUX – Initiatives et Changement, are governed by Swiss law. The place of jurisdiction is Montreux, Switzerland, where the foundation is officially registered. This ensures that any potential dispute is resolved fairly and locally, in accordance with Swiss legal standards.

Contract & Confirmation

A booking is considered confirmed once a formal written agreement is signed by both parties within the timeframe specified in your offer. The signed contract includes key details such as event dates, services, participant numbers, pricing, and terms of cancellation.

Payment Terms

Payment terms and deposit schedules are clearly outlined in each individual contract. Payment is typically made by bank transfer or credit card. Cash payments may require prior agreement. Failure to meet payment deadlines may result in cancellation and the application of cancellation fees as defined in your contract.

Cancellations & Changes

Our cancellation and change policy is outlined in your signed contract and may vary depending on the nature, size, and timing of your event. In general, cancellations, significant reductions in participant numbers, or major changes to services may incur fees. These terms are designed to reflect the planning and resource commitments made in advance of your event. We encourage early and transparent communication should any changes arise, so we can work together to find reasonable solutions while minimizing disruption for all parties involved.

Force Majeure

Neither party shall be held liable for any failure to perform its obligations if such failure results from a force majeure event—defined as an unforeseeable and extraordinary circumstance beyond the reasonable control of either party, which makes it impossible or unsafe to hold the event or fulfil the agreement. Force majeure events may include, but are not limited to: natural disasters, acts of war or terrorism, civil unrest, government-imposed restrictions, or officially declared public health emergencies. Force majeure does not cover situations arising from internal changes, poor planning, or general inconvenience. In such cases, both parties agree to communicate promptly and work in good faith to reschedule the event. If rescheduling is not possible, any refund or adjustment will take into account reasonable, non-recoverable expenses already incurred by the venue. Under no circumstances shall either party be liable for indirect, consequential, or punitive damages related to a force majeure cancellation.

Tourist Tax

A CHF 5.00 tourist tax per adult, per night applies to all stays. It is free for children under 16. This tax includes the Montreux Riviera Card, which offers free public transport (including Caux–Montreux) and discounts on local attractions.
